Non receipt of EMD and Tender form fee before closing of bid will result in rejection of bid. **Micro, Small & Medium Enterprises** registered with the National Small Industries Corporation Limited, New Delhi, are exempted from the payment of EMD. Such bidders should submit the proof of exemption along with tender document.

General Conditions :

1. The receipt of payment and tender document at KSTC on specified time will be responsibility of the bidder. The KSTC shall have no responsibility for any technical issue/ delays from the bidders end for non-receipt of tenders.
2. The contract will be awarded to the bidder who has quoted the lowest (L1) at the negotiated price, subject to the condition that the price is comparable with market price and bidder has the capacity and resources to carry out the contract effectively and timely.
3. Except taxes (GST) and customs duty, the Bidder’s price must be firm throughout the period of the contract and there shall be no revision of the rates quoted by the bidder for any reason whatsoever.
4. The tender shall remain valid for acceptance for a period of **30 days** from the date of tender opening.
5. The KSTC does not bind itself to accept the lowest tender, if they do not agree with the terms and conditions, payment condition and delivery period.
6. Any defect developed within the “Warranty Period from the date of commissioning of the machine/ purchase of the goods/accessories have to be rectified by the supplier at their own cost/risk. In case the supplier does not rectify the defects, KSTC or its representative shall get the work done at the risk and cost of the supplier.
7. All pages of Tender Document should be signed and sealed and to be uploaded as a token of acceptance of all terms and conditions.
8. No variations or modifications of the terms of the contract shall be made except by written amendment signed by the parties. KSTC reserves the right to withdraw the offer at any time before the final agreement without assigning any reasons thereof.



9. Payment terms: 10% of base value at the time of order confirmation by the supplier, 80% amount with all taxes and duties will be paid after successful arrival of goods at site. Balance 10% of base value will be paid on successful erection/ commissioning/ trial run of machine, subject to the condition of submission of Performance Guarantee.
10. **Performance Guarantee:** The successful bidder has to produce an interest free security deposit equivalent to 5% of the total value of the contract in the form of deposit at KSTC or Bank Guarantee, for the period of 60 days beyond the period of defect liability period including warranty obligation, as the Performance Guarantee.
11. **Delivery :** Delivery should be within 30-45 days from the date of payment of advance or mutually agreed delivery terms.
12. **Penalty :** If the successful bidder fails to complete the supply/ work within the period of completion or within any extended time allowed, the successful bidder shall pay the client an amount equivalent to 0.5% of value of unfinished work/ contract value for every week of delay or part thereof subject to a maximum of 10% of contract value as liquidated damages.
13. This document constitutes no form of commitment on the part of the KSTC other than to provide further information on the tender notice. Furthermore, this document confers neither the right nor an expectation on any manufacturer / authorized supplier to participate in the proposed process of inviting external investment.
14. KSTC reserves the right to withdraw from the tender process or any part thereof, to accept or reject any / all offer(s) at any stage of the process for empanelment or after empanelment and / or modify the process or any part thereof or to vary any terms without assigning any reasons. No financial obligations will accrue to KSTC in such an event. KSTC shall not be responsible for non-receipt of correspondences by post / e-mail / courier / fax etc.
15. The interested manufacturer / authorized supplier shall bear all costs / expenses associated with the preparation and submission of the bids / offer for this tender. KSTC shall not, under any circumstances, be responsible or liable for any such costs / expenses whether direct, incidental or consequential.
